Financial Report and 2022 Budget - Brian Brakke

o 2022 Results

- We were able to make budget for 2022
 - Top line revenue exceeded budget
 - Expenses were also below budget
 - We had been forecasting a decrease in surplus of $^{\sim}$ \$55K and we were able to end the year with only a deficit of $^{\sim}$ \$6K
- Mortgage was refinanced in May of 2022 at the same rate 4.25% with 15 year amortization (up from 10 years to help with cash flow)

2023 Budget

- Income and Expense projections are down for 2023
 - Income projections are a result of stewardship campaign
 - Increase in Wednesday Night Supper revenues
 - Expenses are projected to go down
 - Highlights included 3% increase in payroll, health insurance, Director of Operations decrease in hours, Director of Ministries position being hired, office expense negotiation decreased expenses, benevolence decrease.
- We will be using the PPP loan to balance the budget

With proposed use of PPP budget in 2023, the remaining balance will be ~\$36K

- Stewardship committee goal for 2023 to get 142 pledges and \$675K
 - Actual received 134 for \$471K
 - 3 new estimates of giving
 - 72 Increased giving
 - 49 remained the same
 - 13 reduced
- Landscape project cost \$93,400
 - Financed through memorials and gifts, challenge to members and asset renewal
 - Still ahead in 2023 sprinkler system and maintenance
