Joint Venture with Joy Lutheran Church – Parker, CO and Agape (Pastor Kelli)

Joy Lutheran Church will be coming to the cities from Colorado for their high school summer trip. They had originally planned on the youth gathering, but since it was canceled, they are creating their own youth gathering lite. They would like to have Dave Scherer (AGAPE*) come and perform but are looking for a congregation to host him. Dave is our (only?) ELCA rapper. Their pastor, Ryan Jerome, used to be on staff at Mount Calvary, so they asked if we would be willing to host. I propose we make a motion to host Dave's performance on Wednesday, July 27 and waive our building fees for the event. Dave charges roughly \$1500 to perform- they are not asking us to contribute to his fees but are inviting us to join them if we would like.

New Business – Discussion/Information

• Landscaping project funding (Pastor Tom)

Members of the Executive Council and Finance Team met to discuss funding options for the landscaping project. We all have homework to do before we meet again, but we will have a plan for the council in May to hopefully be voted upon at the May annual meeting.

- Phase 1 \$54-\$75K (thinking average of \$66K possibly using part of asset renewal along with other allotted money and donations)
- o 2rd phase total was over \$100K
- o 3rd phase included space in between the buildings
- This all needs to be approved by the congregation on the May 22nd (council will vote on the what is going to the congregation on May 17th)
- Synod ministry grants (Pastor Tom)

We applied for a grant from the Synod for our front yard landscaping project. We felt it was an invitation to our surrounding community to use the green space area. We were not awarded any funds.

Sexual misconduct/youth protection policy revision (Pastor Kelli)

Mount Calvary received a request from Grinnell, our insurance company, regarding a change to this policy. The change requested was to always have two adults with youth and children for all church activities. Pastor Kelli and NaDyne met with our church insurance agent to discuss this request and share our concerns that we would not be able to guarantee two adults for all activities. Our insurance agent assured us that this was a request and not a policy requirement. Our coverage would not be impacted. We shared that doors are left open if meetings are in rooms or the gatherings are in large areas where anyone can walk through. He felt that this was sufficient and that we did not need to change our policy.
