Motions since previous meeting

6/12/2022 via email - Motion to update the Church's mask policy to make masks mandatory inside only when the CDC County levels are at red. This will apply to VBS and Sunday services effective immediately. Staff and congregation may still wear masks at their discretion.

Finance Updates – Eric Baertsch (loan)

- Loan refinance: due to mature in September. Talked to banker and they were able to lock in a rate of 4.25% (same as previous rate) for 5 years signed 10 year note, but after 5 years the rate will fluctuate.
 - o Loan also stretched out to 15 years, which will save money on the payments
- YTD income and expenses are flat but we are above plan
 Offering income is running 99% of budget
- Dedicated fund report council reserve we have spent 2,015 (lights) and the speakers are coming in under budget (roughly \$4K rather than \$12K)
- Phone system may change course on providers due to customer service
 - 4 of the staff is on the list for cell phone reimbursement. The other 3 currently do not but will be required to use their cell phone at work. Finance committee approved a partial reimbursement.
 - If they change systems again, it shouldn't change the finances much

Old Business

- Refugee fundraising update (Pastor Kelli)
 - o Collecting move in kits
 - o SJ came and preached last Sunday from that organization

- Kelli called the organization to see if there are any other service opportunities
- There will be an email update tomorrow on giving
- Youth trip fundraiser update (Pastor Kelli)
 - o Raised \$2400 so far
- Twin Cities Bronze practice and storage space (NaDyne)
 - There are no other churches that do something like this
 - \$100/month for 1 year storage and practice time with 3 concerts

• They do have insurance which we will get a copy of and submit to our insurance

 - NaDyne will check with Bob on running electrical outside as well
 - Shade has also come up as well still no plans

 - There were a lot of people open to changes in other types of music (guitar came up quite a bit, organ was not number 1)
